



### **Company Overview**

BCA operates a fleet of 44 Airbus aircraft (25 A-319 and 19 A-320). It is one of the youngest and largest Airbus fleets in China with an average age of less than 4 years per aircraft.

Safety management is the highest priority for BCA which is clear from their perfect safety record after more than 15 years of flight operations. Currently BCA has almost 20 foreign pilots who come from all over the world including, Canada, Great Britain, Mexico, South Korea, the United States, and others.

- With No History of Incidents or Accidents Report issued by last employer or aviation authority of his/her country
- With notarized No Criminal Record

\*Peak season: from Jan. 1<sup>st</sup> to Mar. 15<sup>th</sup>, from Jul. 1<sup>st</sup> to Oct. 15<sup>th</sup> each year

Off-peak season: from Mar. 16<sup>th</sup> to Jun. 30<sup>th</sup>, from Oct. 16<sup>th</sup> to Dec. 31<sup>st</sup>

\*Once get hired, foreign pilots get paid 8,800 USD from the date of joining till he/she passes the line check for no more than 6 weeks. Capital Airlines supply the accommodation during this period of time. In case that foreign pilot does not attend the line check within 6 weeks, he/she will start to be paid 11,000 USD until he/she passes the line check.

\*Pilots who finished the first year service are entitled to change the option. Every pilot can change the option once within the 3 years contract length.

**Foreign pilots enrolled BCA after 1st Jan,2016, the service fee will be raised from 1000 USD/pilot/month to 1500 USD/pilot/month (For those pilots who were recommended by BCA, the service fee will stay 700 USD/pilot/month).**
